Compensation levels were reviewed for market competitiveness and reasonableness and were compared for all components of pay including cash compensation, benefits and perquisites. In preparation for such reviews, the consultants interviewed a number of University officers and members of the Board of Trustees to gain perspective on the University's work environment mission, pay philosophies and pay program effectiveness. The results included individual market reports as well as an aggregate perspective. The Compensation Committee of the Board of Trustees approved the resulting reviews and compensation levels of the president and his direct reports and proposed the adoption of a related executive compensation philosophy which was ultimately approved in January of 2010 by the full board. The compensation reviews covered all senior employees (earning over \$100,000), including individuals not reporting directly to the president. These reviews, although conducted in a previous fiscal year, were fully vetted by the Compensation Committee and full board in fiscal year 2013-2014. All such actions were reflected in the minutes of both the Compensation Committee and the Board of Trustees. Any compensation changes made were relative to the independent market review. During fiscal year 2013-2014 a full external review of the President's compensation was conducted consistent with specifications outlined above in the prior review. The review was conducted and results were prepared by consulting firm, Findley Davies in preparation for the renewal of the President's contract. The compensation committee of the board and ultimately the full board voted to approve the new contract including the fully vetted new compensation levels. The board was given a deep and thorough view into the compensation studies as prepared by Findley Davies, all of which is reflected in board minutes.
