Gathered signatures of neighbors of proposed site to show community's support for the proposal. Attended local community meetings and set up tables at Love Your Park Day to discuss the proposal, foster community discussion and gather feedback and ideas for the development and management of the garden. Grow Philly then developed a comprehensive site design and management plan and completed a formal application for the City of Philadelphia (approval pending).

Organized and sponsored free indoor soccer tournaments for youth in South Philadelphia. Recruited and trained referees/volunteers. Average participation was ~50-60 youth players and ~20-30 community members in attendance, per tournament.

In tax year 2013 we completed a significant re-design and expansion of our website, to improve our ability to educate and engage the community.
