The Mexican American Catholic College is an institution of higher learning offering a bi-literate, multicultural formation program that can lead to a BA and an MA in Pastoral Ministry. Educational programs focused on pastoral, leadership and language development that provide training and research relating to culture and ethics of Hispanics in the United States. Participants in these programs totaled 515 for the year ended July 31, 2014 of which degree based amounted to 137 students; and continuing education amounted to 378 students. The MACC Ministry Formation Program (with its three components of the Mini Pastoral, Hispanic Pastoral Ministry, and Language Studies) is accredited through the United States Conference of Catholic Bishops Commission on Certification and Accreditation.
