Each year, the Young Life board of trustees reviews the executive director's compensation package (including benefits). The Young Life board relies on the use of comparability data in making their decision, and final approval is subject to a board vote. A real time compensation service computer program is used to run comparability data on individuals holding similar positions within the region. This data was used as the basis for determining the amount of compensation for the year. A representative of the MCYM board met with and discussed compensation arrangements with a human resources executive, and representatives of both Young Life and Youth For Christ in order to gather comparability data. Although the executive director is clearly an employee of Young Life with compensation ultimately set and paid by Young Life, Young Life consults with members of the MCYM Executive Committee on his compensation and shares responsibility with MCYM for determining appropriate compensation. The MCYM Executive Committee reviewed comparability data and voted to approve the compensation paid to the executive director by Young Life.</p>

Thus, the value of these contributions are properly included in the audited financial statements of Military Community Youth Ministries in revenues and program expenses. Military Community Youth Ministries would prefer to include the value of donated services and facilities in the organization's Form 990. We believe this shows the reader a more complete and accurate picture of the financial activities of the organization for the year. Nevertheless, because of the IRS' specific requirements, contributions of donated services and facilities have not been reported as contribution revenue on Form 990, Part VIII, Line 1f. Correspondingly, the associated program expenses have not been reported in Form 990, Part IX, Column B. (You will find the reconciliation of the audited financial statements to Form 990 on Schedule D, Parts XI and XII, where these differences are enumerated.) If the amounts were included on Form 990, Program Service expenses (Form 990, Part IX, Column B) would increase by \$3,641,655. In addition, revenues (Part VIII, Line 1f) would increase by the \$3,641,655. More important to readers of Form 990, the functional expense percentages (as reported in the audited financial statements) should be as follows: PROGRAM SERVICE EXPENSES - 90.9%, MANAGEMENT AND GENERAL EXPENSES - 7.4%, FUNDRAISING - 1.7%.</p>
