Scholarship Program. The scholarship committee reviewed applications and College Board evaluations from 75 applicants to 14 different AMI training centers in the United States. Of these applicants, 22 were awarded scholarships totaling \$51,130 - an increase of approximately \$24,000 over last year in large part due to the contribution from AMI/USA. Awards ranged from \$770 to \$3,480, with the median award being \$2,380. This program is supported by contributions.
