

The certificate of formation of Dixie Baseball Inc was amended in July 2013 as follows:

- (1) Added new Article III "Non-Profit Corporation" to describe the non-profit purpose of the Corporation;**
- (2) Article VI "Board of Directors" - added provision that the qualifications for Board membership shall be provided for in the Bylaws;**
- (3) Article VIII was deleted and Article VII states the terms of directors shall be set forth in the bylaws**
- (4) Article IX was deleted and Article VII states vacancies shall be filled in a manner set forth in the bylaws**
- (5) Original Article X "No Director/Officer Compensation" has been deleted and such provisions are set forth in the bylaws**
- (6) Added new Article X "Indemnification" to provide for indemnification of the officers and directors**
- (7) Add new Article XI " Prohibited Activities" to enumerate prohibited activities of the Corporation to maintain its 501(c)(3) tax exempt status;**
- (8) Article XII was amended to provide updated language for the distribution of assets upon dissolution of the Corporation**
