THE ANNUAL CAMPAIGN WAS OUR LARGEST PROGRAM FOR THE 2013-2014 SCHOOL YEAR. THE CAMPAIGN RAISED \$535,927. THE FUNDS WERE USED IN THE FOLLOWING AREAS: OPERATIONS, STAFF DEVELOPMENT, TECHNOLOGY, SCHOLARSHIPS, ATHLETICS, FINE ARTS, PARENTS ASSOCIATION, AND BENEVOLENCE.

THE PARENTS ASSOCIATION IS THE SECOND LARGEST SERVICE PROGRAM. IT IS A PARENT VOLUNTEER GROUP THAT SUPPORTS THE OPERATIONS OF THE SCHOOL. SOURCES OF REVENUE ARE \$20,000 FROM THE ANNUAL CAMPAIGN, AND THE NET PROCEEDS OF THE DISTINGUISHED SPEAKER LUNCHEON WHICH TOTALLED \$284,448. THE PARENTS ASSOCIATION HAS EXPENSES FOR THE FOLLOWING: ORGANIZING THE PARENT SCHOOL COFFEE AT THE BEGINNING OF THE YEAR, PROVIDING THE TEACHER APPRECIATION LUNCHESES, PURCHASING COFFEE FOR THE SCHOOL WORKROOMS, TEACHER CHRISTMAS BONUSES, SALARY INCREASES, AND PRINTING THE SCHOOL DIRECTORY. IN ADDITION, IT IS THE UMBRELLA ORGANIZATION THAT HOUSES ALL PARENT VOLUNTEERS.

THE EAGLE ATHLETIC BOOSTER CLUB IS OUR THIRD LARGEST PROGRAM. THE EABC RAISES MONEY TO SUPPORT THE ATHLETIC PROGRAMS AT SECOND BAPTIST SCHOOL. REVENUES TOTALLED \$201,849 AND CAME PRIMARILY FROM THE FOLLOWING AREAS: MEMBERSHIPS, CONCESSIONS, MERCHANDISE, HOMECOMING, SPRING SWING, FLIGHT NIGHT, YARD SIGNS. NET INCOME OVER EXPENSES WAS GRANTED TO THE SCHOOL ATHLETIC DEPARTMENT TO PAY FOR UNIFORMS, EQUIPMENT, AND PLAY-OFF EXPENSES.

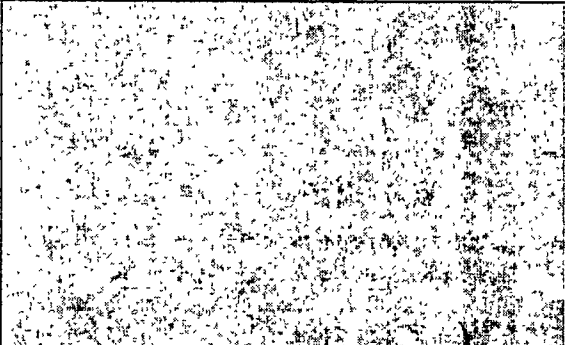
