CILE is a separate 501(c)(3) entity composed of 4 American Bar Association (ABA) accredited, independent law schools including California Western School of Law, New England Law Boston, South Texas College of Law, and William Mitchell College of Law. Each law school within CILE administers at least one summer abroad program each year in which students take legal coursework exposing them to international and comparative law and culture. The School tracks the program revenue and expenses for CILE. Any excess revenue over expenses is paid to CILE and any excess expenses over revenue are reimbursed by CILE to the School. The activity listed for this program will also be included on the separate Form 990 OF CILE and includes all program expenses. Creative Problem Solving - The Center for Creative Problem Solving develops curriculum, research, and projects to educate students and lawyers in methods for preventing problems where possible, and creatively solving those problems that do exist. The expenses disclosed herein represent costs incurred in various foreign countries while working on such programs. International Legal Studies - Several of the School's faculty members specialize in international legal studies and travel to various foreign countries to perform research and to meet other international and comparative law and culture specialists. All expenses related to these trips are disclosed herein. ACCESO Capacitacion is a program devoted to training lawyers and law enforcement in and from Latin America and assisting with institutional transitions from the inquisitorial to the adversarial system of criminal procedure and the introduction of oral trials. In addition, this program works with Latin American lawyers to establish innocence projects in their countries and provides guidance on how to seek release of those convicted unjustly as well as train lawyers and collaborate on legal reform issues that are related to the unjust sentences. This program includes travel by California Western School of Law employees and volunteers to Latin America to attend training programs, conferences and meetings. The Mexico Rule of Law - Oral Trial Moot Court competition grant provides Mexican law students an opportunity to develop oral advocacy skills for Mexico's new criminal justice system. The students are taught skills to prepare them for both the pre-trial and the trial phases of a court hearing. To accomplish the skills training, grant staff produce online videos, webinars, and competitions. Selected team coach trainings and competitions are held in cities throughout Mexico under the direction of the grant staff. There are four Regional competitions (held in Mexico), one Finals competition (held in Mexico), and one Super competition (held in the U.S.).
