28 Stepping Stones Project currently has eight Coming of Age groups that serve 50 middle schoolers, grades 6-8, and two groups that serve 11 high schoolers, grades 9 and 10 We have 12 paid group leaders who are paid for 10 hours per month, 4 that are paid on average 3 hours per month, one half-time staff member who works 20 hours per week and one quarter time staff member who works 10 hours per week The Coming of Age groups meet on average two times per month, with a total average of six hours of face time per month During the groups the youth participate in activities, council, and sometimes nature hikes The groups go on a 2-3 day backpacking trip each summer Each pair of group leaders has a mentor that they consult with one hour per month, and all leaders attend a two-hour peer consultation meeting twice every quarter (Grants \$ 107,088) If this amount includes foreign grants, check here
