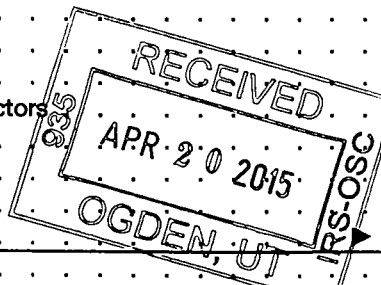

Understanding Disabilities, Inc. provides disability awareness programming in the Reading public schools and community, to help children see beyond people's disabilities and focus on the ways we're all the same inside.

PART III, LINE 28

UD's elementary and middle school programs encourage an awareness of all that people with disabilities can do and promote a culture of inclusion and respect.

UD programming is taught in each of Reading's five elementary schools and two middle schools. Our elementary school programs teach about and allow greater understanding of a range of physical, sensory, and developmental disabilities. The curriculum includes age-appropriate instruction as well as hands-on activities for deeper learning. A hallmark of UD programming is the opportunity to meet with guest speakers who share about their experience living with a disability. Children learn we are all the same inside, and that it is possible to reach out in friendship to someone who may initially seem a bit different from you.

\$12,549

In addition to the cash outlay, an additional \$28,361 was expended through donated time and facilities.
