Notes to Financial Statements

Note 1 – Summary of Significant Accounting Policies

Nature of Business – WESPAC Foundation, Inc. (the “Organization”) was formed and incorporated as a not-for-profit corporation under New York State law and accordingly has been recognized as a tax-exempt charitable organization under section 501(c)(3) of the Internal Revenue Code. The Organization is dedicated to provide human right and current affairs education through public meetings, events, conferences and newsletters.

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles. The accrual method recognizes revenue when earned and expenses when incurred.

Cash and Cash Equivalents – For the purposes of the statement of cash flows, the Organization considers all highly liquid investments with an original maturity of less than three months to be cash equivalents.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

Functional Expenses – The costs of providing various programs have been reported on a functional basis in the statement of activities and in the statement of functional expenses. Accordingly, certain costs have been allocated among various programs and supporting services based on estimates made by management. All fundraising activities were conducted by volunteers.

Credit Risk – WESPAC Foundation, Inc. maintains bank accounts at HSBC and Axiom Capital Management, Inc.; neither of which, as of the date of this report, have balances in excess of federally insured limits.

Contributions – The Organization receives contributions and records them as unrestricted or temporarily restricted support, depending on the existence and/or nature of any donor restrictions.

Income Taxes – The Organization is exempt from income taxes as defined by Internal Revenue Code 501(c)(3). Therefore, there is no provision for income taxes in the accompanying financial statements.

Investments – The Organization adopted SFAS No.124, “Accounting for Certain Investments Held by Not-for-Profit Organizations,” in 2001. Under SFAS No. 124, investments in marketable securities with readily determinable fair values are reported at their fair values in the statement of financial position.

Property and Equipment – Purchases of property & equipment are recorded at cost. Donations of property and equipment are recorded as support at their estimated fair value. Such donations are reported as unrestricted support unless the donor has restricted the donated asset to a specific purpose. Property and equipment are depreciated using the straight-line method over the expected useful lives of the assets.

Contributed Services – During the year ended August 31, 2014 the value of contributed services meeting the requirements for recognition in the financial statements was not material and has not been recorded. In addition, many individuals volunteer their time and perform a variety of tasks that assist the Organization, but these services do not meet the criteria for recognition as a contributed service.
