Our afterschool programming served 2,300 students at 12 schools through a wide variety of arts education classes, including Musical Mania!, a musical theatre class, Dance Around the World, a dance training class in styles such as Afro-Caribbean, Indian and Hip Hop, Flicker Filmmaking, which enables young people to write and edit a short video, and Art Attack, where students draw, paint, and sculpt We specialize in long-term commitments to schools, all of our school partners have renewed their participation in our programs during the past three years The Wingspan Arts afterschool is our longest running program, founded in 2001 in response to the inadequate arts education in public schools Through the afterschool program, students gain weekly exposure to the arts, exploring their creative potential and building self-confidence that will shape their lives forever

Summer Conservatory provides free, pre-professional theatre training to 75 students in the 6th through 12th grades each year By offering tuition-free arts training, the program most fully exemplifies our mission by concentrating on the unique goals and skills of our students through a combination of theory, practice, and the focused attention of professional teaching artists In thirteen years, the program has served more than 900 students We offer the only tuition-free theatre pre-professional training program in NYC that culminates in full-scale productions Students spend the summer acting, singing, and dancing while developing skills and friendships that will benefit them for their entire lives

In FY14, our in-school programming served 3,000 students at 11 schools Professional teaching artists provided Pre-K to 12th grade students with training in visual arts, theatre, dance, music, and media arts as well as arts-based gym classes 73% of our students are from low-income families Students gain a better understanding of the world as they study, learn to perform, and express their feelings through the arts Our objective is to design and implement curriculum that not only educates students about the arts but also positively impacts their overall social-emotional, cognitive, and academic development
