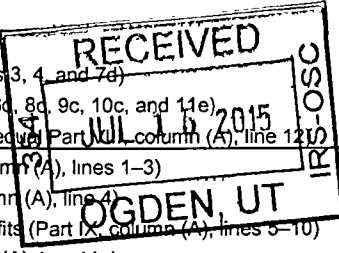

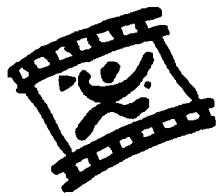

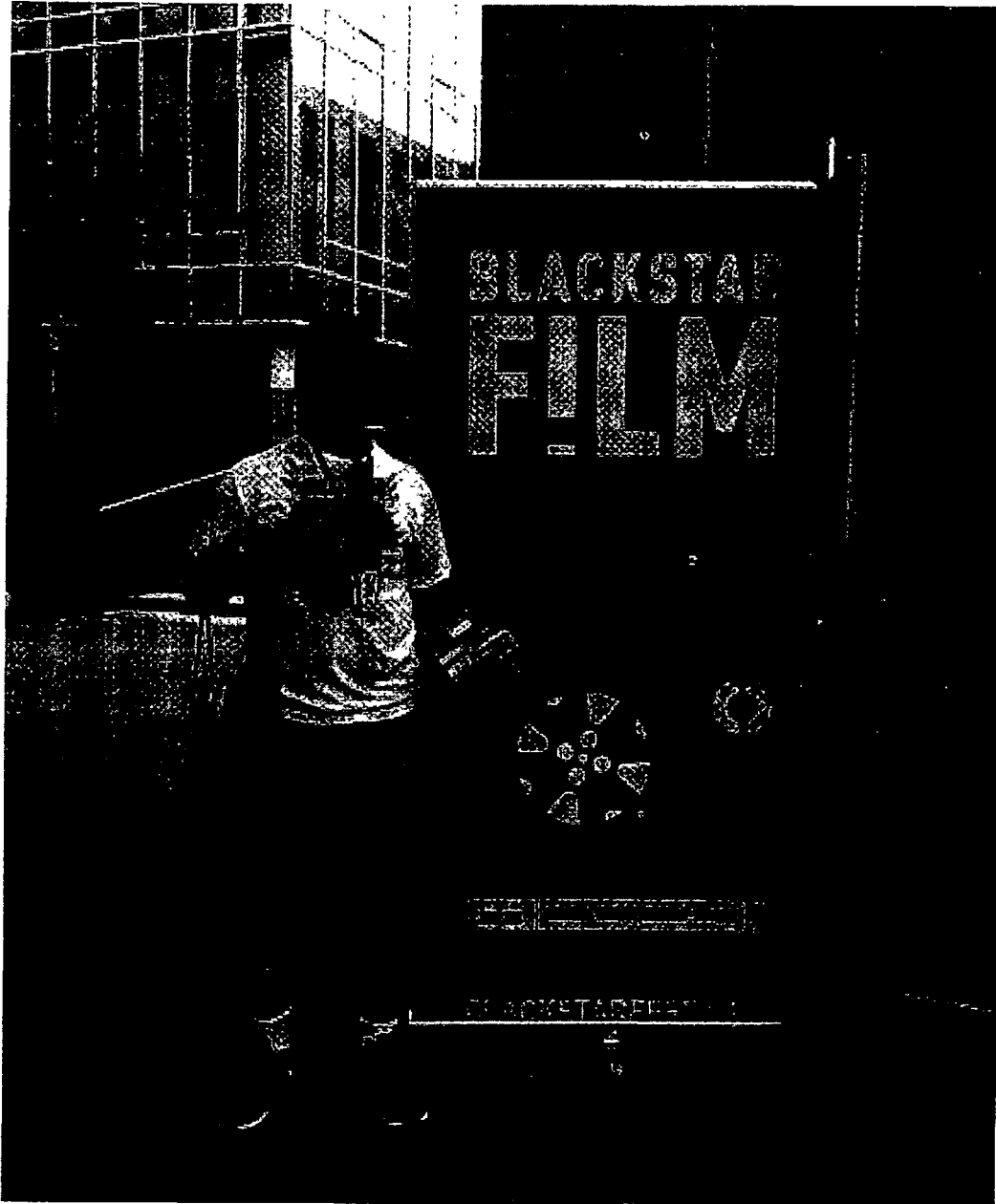

- New BPA students met with NBC10's News Director Anzio Williams and pitching their film concepts to BPA's Executive Director Teri Yago Ryan plus REEL Mckoy Media's Sean Mckoy, and NBC creative executives, Nicole Ross Giles from the Greater Philadelphia Film Office, BPA Board member Kharisma McIlwayne (BPA Alumna and broadcast professional!) and Benjamin Barnett (Exec Dir. Philadelphia Independent Film Festival) to get 'greenlit' for their summer filmmaking projects;
- In addition to visiting NBC, youth from our summer filmmaking program at New Media visited Lenfest Media pitched their film concepts to industry pro (former Comcast Executive and longtime broadcast television guru Jon Gorchow (who is also a former BPA Board member!) after he took them around the studio and answered lots of questions about getting into the 'biz'.
- Alums Nestor Tamayo, Amy Flores, Zyira Fitzgerald, and others worked on preparation/development for an exciting upcoming day-long 'boot camp' we will be running for Young President's Organization in September where we will take 40+ families on a filmmaking challenge in just one day with our partners at Philadelphia Museum of Art. We hope this will raise awareness and support of BPA from this philanthropic community.
- We began work on an exciting initiative with our friends at the Mayor's Managing Director's office – PhillyRISING – a city-wide effort to reduce youth violence. Stay tuned for more updates on this program and the Philadelphia Youth Media Spotlight program *powered by Big Picture Alliance*.
- BPA Students from our New Media Technology Spring semester program's film "Honor's Class" was selected to screen out of hundreds of submissions at Blackstar Film Festival in August – this was exciting for our young filmmakers to participate as visiting filmmakers and great community-wide impact to showcase their work to the general public.

2014 - Big Picture Alliance Achievements

THE RAND REPORT

Some exciting news came from our pilot year of work with our collaborative partners at the School District of Philadelphia & Philadelphia Youth Network. Researchers from Rand Corporation on behalf of the Bill & Melinda Gates Foundation found the following after studying our program:

- Youth participants in BPA scored higher on their Spring Benchmarks than their daytime counterparts not enrolled in BPA.
- Youth participants in BPA maintained a 5.7% higher attendance rate than their peers/daytime counterparts – these rates were another 2-3% higher than the School District of Philadelphia general attendance rate as well.
- Youth participants in BPA had a promotion to next grade percentage rate 7% higher than their peers/daytime counterparts.

We are proud of this work and hope to bring our model to new districts in the coming year.

2014 HIGHLIGHTS -- BPA Students:

- Continued to earn credit toward their daytime English Classes and were a few of the first in the US to earn online badges as part of our pilot project! 25 more youth in total earned online badges in Collaboration, Storytelling/Writing, Technical and Editing.
- Worked on community driven projects like our Salvation Army collaborative project working with youth at West Philadelphia Corps, TempleCorps, Tabernacle and more to explore learning around energy conservation – this finished film project won a PECO-PEEPS award for the second time in a row – way to go BPA!
- Students at PHMC/BIPS (Behavioral Intervention Prevention Services) in West Philadelphia worked on short personal films in the Fall/Spring about themselves and their community in West Philadelphia which culminated in a community-wide premiere.
