THIS YEAR ALSO MARKED THE BEGINNING OF A NEW COMMUNITY-BASED PROJECT CALLED JOURNEY FROM THE EAST. EDUCATION OFFERED FOURTEEN THEATRE ARTS RESIDENCIES IN AREA SCHOOLS AND TWO SUMMER PROGRAMS, TEEN ENSEMBLE AND CAMP TOUCHSTONE, ONSITE AT THE THEATRE, REACHING HUNDREDS OF AREA YOUTH THROUGHOUT THE SEASON.
