Touching Lives Worldwide is a Christian organization devoted to serving God through serving others The organization always strives to demonstrate the great love of God and give hope to hurting and needy people They have continually reached out to thousands of people to help with their physical and spiritual needs They have touched lives of thousands of children through providing for their needs whether it be food, shelter, clothing, medical care, education or just some love & affection

Although they do a lot of mission work right here in the United States, Touching Lives Worldwides primary focus and work, during this past fiscal year, has been in Haiti and the Dominican Republic There have been many programs and projects in place over the previous fiscal years, and, these continue to thrive In addition, there has been some expansion of these programs and projects as well as new ones started From the beginning of Touching Lives Worldwide, Inc it has always been the one to start and fully pay for any of the programs, projects, or activities However, it helped to charter a certified non-profit corporation in the Dominican Republic to do the charity and mission work there as a partner with Touching Lives Worldwide This non-profit organization is called God Is Touching Lives In D R , Inc , and, Touching Lives Worldwide makes monthly donations to this organization so they can work in a partnership to do the many things that are done The end result is, through this partnership, thousands of lives are touched and helped in physical and spiritual ways There are dozens of volunteers, from the United States, that have and continue to give of their time, talents, and money to help with the many accomplishments The following is some of the ongoing things that show the activities and accomplishments of Touching Lives Worldwide, Inc 1) In Quanamithe, Haiti, the organization totally supports an orphanage by providing the food, clothing, some shelter, medical care, dental care, education, & more These children, before the help of the organization, were starving, desperate, and hopeless Now, they get healthy meals each day, and, as needed, they get clothing, shoes, healthcare, and numerous other things including lots of love & affection To see children, that lived on the streets and searched for food in trash piles, now have a home and the necessities of life is a real accomplishment 2) In Dajabon, Dominican Republic, the organization has a special school for deaf children This school came in to existence because TOUCHING LIVES WORLDWIDE discovered that there were hundreds of children both in Haiti and the Dominican Republic that had no school to attend In fact, these deaf children had never been taught any way of communicating They were treated as outcasts because many people believed that they were deaf because they had "evil spirits" In many cases, even the parents and their siblings rejected them Therefore, they were growing up in a lonely and isolated world not even knowing their name, age, or how to tell time or what colors were However, all of this changed when the organization started the special school for them The school consists of children from both Haiti and the Dominican Republic The kids are doing very well because they now have a way of communicating as well as a purpose to get up for each day They go to school to learn but there is so much more that they get from Touching Lives School for the Deaf To see the children's lives be changed in so many great ways is a real accomplishment through this organization 3) Since the attitudes towards the deaf children has changed and people realize that they are just as human as anyone else, some parents, along with some adults from the business world, wanted Touching Lives to teach them how to communicate with the deaf Therefore, the organization now has adult ASL (American Sign Language) classes This is an accomplishment of taking ignorant people, about the deaf, to a new level of understanding and respect for all deaf people 4) Touching Lives Worldwide has been recruiting, organizing, directing and hosting medical and dental teams to fulfill the many dire needs of the people of Haiti and the Dominican Republic 5) In Dajabon, the organization has five English/Bible classes each week for people of all ages Through these classes Touching Lives Worldwide teaches hundreds of people English as well as teaching them the Bible 6) The Touching Lives Summer Camps is a time that the organization brings poor and very needy children from Haiti and the Dominican Republic together for a fun time of learning, playing, eating, sports, and lots of love and affection These children are normally the age of 7 to 12 years old Many American volunteers come to help with this big and exciting event 7) In the United States, Touching Lives Worldwide helps many people from all walks of life and of all ages The organization provides physical, spiritual, and financial help for some while providing counseling, advice, encouragement, or comfort during times of crisis for others They even help fulfill the needs from loneliness of the elderly The above is a limited list of the overall accomplishments of the organization in the past fiscal year In summary, Touching Lives Worldwide, Inc is a small organization with a very small budget, but, they have accomplished more than many larger organizations that have a budget many times
