The James Alan Cox Foundation provides financial support to student photographers of high-school and college age through a variety of funding, including equipment and scholarships, to expand educational and developmental opportunities for students demonstrating talent, interest and financial need This past year, the Foundation again awarded 5 high school students high-end digital cameras (worth \$779.99 each) and awarded \$2,500 scholarships to 6 college students (payable to their school) The Foundation also funded its third annual internship program at Jim Cox's former TV Station, KTVK-3TV. We funded the cost of compensation to the intern and the company's matching taxes (\$1,973). In the past, the Foundation has also purchased an editing bay (\$10,000) at Arizona State University, purchased high-end cameras for Huntington High School, New York, purchased recording equipment for Hopi High School in Keams Canyon, Arizona, and purchased or given gently used camera equipment to the Daniel Pearl Magnet School in Van Nuys, California, the George Washington Carver Museum in Austin, Texas, the Duke Ellington School of the Arts in Washington D.C., and the SEED Public Charter School in Washington, D.C.
