THE HUDDLESTON FARMHOUSE IN CAMBRIDGE CITY IS AN 1841 FARMHOUSE LOCATED ON THE NATIONAL ROAD, WHICH SERVED AS A INN FOR SETTLERS HEADING WESTWARD. THIS FARMHOUSE ALSO OPERATES AS THE NATIONAL ROAD HERITAGE SITE, WITH EXHIBITS OFFERING A GLIMPSE OF CROSS COUNTY TRAVEL ON THIS HISTORIC BYWAY. VERAESTAU IN AURORA, INDIANA, IS A HISTORIC HOME SET HIGH ABOVE THE OHIO RIVER. PORTIONS OF THIS BUILDING DATE TO 1837. THE PROPERTY IS OPEN FOR TOURS AND EVENTS, AND ALSO SERVES AS A FIELD OFFICE FOR SOUTH EAST INDIANA. THESE MUSEUMS ARE OPERATED TO INCREASE PUBLIC AWARENESS AND TO EDUCATE THE PUBLIC REGARDING INDIANA'S HISTORY AND THE DESIRABILITY OF RESTORING AND PRESERVING HISTORIC PROPERTIES.

IN ORANGE COUNTY, INDIANA, INDIANA LANDMARKS PROVIDES TOURS OF THE HISTORIC WEST BADEN SPRINGS HOTEL AND THE FRENCH LICK SPRINGS HOTEL. THE TOURS OF THE HOTEL AND THE SURROUNDING GARDENS HIGHLIGHT THE HISTORIC ARCHITECTURE, THE HOTELS' ORIGINS, AND THEIR DECLINE AND REBIRTH THROUGH AWARD-WINNING RESTORATION. TWO GIFT SHOPS WITHIN THE HOTEL PROPERTIES CARRY MERCHANDISE INSPIRED BY THE PAST, INCLUDING BOOKS AND MATERIALS PERTAINING TO THE HISTORY OF INDIANA, ARCHITECTURE, AND HISTORIC PRESERVATION.
