During the year, the Dialysis Center provided almost 31,000 outpatient hemodialysis treatments. More than 3,400 dialysis treatments were provided to hospital inpatients. In addition, the Dialysis Center participates in research programs related to kidney disease and treatment. Employees are encouraged to participate in local and national organizations which foster advancement in renal dialysis.
