Elementary Program - Our holistic after-school program helps DC SCORES students improve their fitness levels by playing soccer, develop their literacy skills and capacity for self-expression by writing poetry, and establish deep community connections through service projects, all while developing closer bonds with teachers and peers Our program follows a school-based model for after-school programming by hiring and training teachers (called our "SCORE Corps" coaches) from each school Each school year, elementary and middle school students participate in over 24 weeks of programming DC SCORES' elementary school program operates five days per week

Middle School Program - The components of the middle school program are similar to the elementary program, with the major difference being that the program operates three days per week

Soccer for Success - Soccer for Success is the U S Soccer Foundation's free soccer-based afterschool program that uses soccer as a tool to combat childhood obesity and promote healthy lifestyles for children in under-resourced urban communities

Program Events - In addition to daily programming, students, coaches and families participate in several city-wide events throughout the school year that showcase and celebrate our students' work with DC SCORES in a fun, positive environment Our events include Fall Frenzy and Jamboree! (city-wide soccer tournaments), and our flagship event, the annual Poetry Slam!

Summer Camp - DC SCORES hosts three camps over six-weeks in the summer Two camps are soccer-only for approximately 150 low-income students The camps are free to the students and families and operate for 5-7 hours/day Our six-week arts and soccer camp enrolls approximately 40 low-income elementary students in a 6-hour daily combination of arts programming and soccer/health programming The arts and soccer camp also employs Summer Youth Employment staff, which are typically high school age youth who have been through the DC SCORES program
