


- a) To cooperate with the public schools and the senior colleges and universities in the articulation of educational programs.
 - b) To promote through research and other related methods the improvement of standards in order to maintain a high quality of instruction and a constantly improving image.
 - c) To provide programs and services that benefit higher education within the State of Texas.
-
