Our visions to enhance the quality of life through the transformative power of live theater and to introduce and enable participation to community members who might otherwise not be able to experience it.**

Five shows and two concerts were produced during the season providing a quality theatrical environment for students and community members to practice their talents, to learn theatre arts, and an opportunity to be involved in local productions and community theatrical enrichment. The five productions were: Of Mice and Men - 45 performances/7,712 attendees; The Lion in Winter - 41 performances/7,750 attendees; Old Times 35 performances/6,403 attendees; Dividing the Estate - 37 performances/7,850 attendees; Tryst - 29 performances/4,910 attendees. The two concerts were: Zorba - 14 performances/2,382 attendees; The Most Happy Fella - 17 performances/3,369 attendees.

The Dramalogue-Talking Theatre! Series gave public presentations of lectures, staged readings and interviews of six theatre legends: Sally Ann Howes, Elia Kazan, George Abbott, Frank Verlizzo, Israel Horovitz, Federico Garcia Lorca. There were 12 performances/ 1655 attendees. These forums allowed for public comment, discussion and education. We also showed 3 documentary films: Brooklyn Castle, Escape Fire and Juxtaposition. There were 5 showings/ 494 attendees.

Approximately 10% of our effort is spent on student educational initiatives, including apprenticeship and intern programs for theatre students. Four Special student performances of Of Mice & Men were held at no charge serving 525 students. Interested students were offered positions to work as apprentices assisting directors, stage managers, light and sound operators, and prop and costume mistresses. Students also had the opportunity to audition and receive guidance from theatre professionals to polish audition techniques, including monologues and song presentations.
