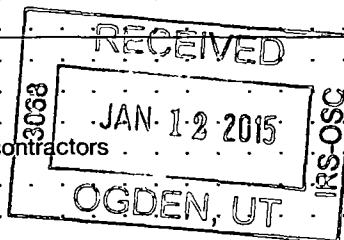

A Voting member can also be held by a partnership or corporation receiving the majority of income from the sale of agricultural products.
