IDRA is an independent, non-profit organization that is dedicated to strengthening public schools to work for all children. Founded on principles of ensuring equality of educational opportunity for every child, IDRA's vanguard leadership, development and research team works with others to create self-renewing schools that value and empower all children, families and communities.

The development fund provides resources for mission and priority program services not supported by external funding and for development of new programs. It facilitates the dissemination of knowledge about best teaching practices in classrooms with diverse students, the creation of materials that specifically address the needs of traditionally underserved students, and research on school finance and other indicators tied to the quality of education that all students receive. On average this fund supports educational services that have a direct impact on 12,000 traditionally underserved students, 500 teachers and 2,000 parents and community members each year. These services have a national focus with particular interest in Texas schools and the creation of equitable educational opportunities for all children.

4b (Code:) (Expenses \$ 660,536 including grants of \$) (Revenue \$)

The Equity Assistance Center is a federally funded project that serves school districts in a five state area: Texas, New Mexico, Louisiana, Oklahoma and Arkansas. On average this project provides services to approximately 2,380 school administrators, 1,100 teachers, 200 parents, and 330 support educational personnel. The technical assistance and training assist schools to implement court ordered desegregation plans and address matters of discrimination in public education based on race, gender and national origin. Center staff work closely with Office for Civil Rights, the U.S. Department of Justice, state education agencies and other similar centers around the country to ensure that all students receive an equitable and high quality education.

4c (Code:) (Expenses \$ 608,049 including grants of \$ 196,150) (Revenue \$)

The Teachers for Today and Tomorrow (T-3) is a five-year project funded by the U.S. Department of Education, Transition to Teacher program. Through T-3, IDRA is selecting, recruiting and retaining competent teachers in multicultural settings who have a passion for teaching and making a difference; is developing a curriculum to certify teachers in bilingual/ESL and STEM subjects in mostly Latino communities; and is providing a comprehensive online and personalized support system to retain teachers for a minimum of three years. T-3 also is expanding the candidate pool to include paraprofessionals, a basic feature of a "grow your own" teacher recruitment approach.

TG-Bridges - The TG-Bridges to Success is funded by the TG Public Benefit Program. Through this program, IDRA will increase its organizational capacity to provide innovative and replicable models of student support by documenting and refining a groundbreaking program of secondary and post-secondary support that provide college success assistance to all students, especially first-time in college Latino students in Texas who have difficulties navigating IHE processes. IDRA is building this organizational capacity by developing and documenting a model based on the Pharr-San Juan-Alamo school district (PSJA) early college district program.

CAMINOS - This project is a five year federally funded project through which IDRA has created a consortium of IDRA, four high-need Texas school districts and universities to certify 150 bilingual and bilingual special education teachers through an accelerated teacher preparation program. The goal of the project is to produce a rigorous accelerated and unique one and one-half year program resulting in a critical mass of highly qualified bilingual/ESL teachers or bilingual/ESL who also will become certified in special education.

PTA Comunitario - PTA Comunitario is a four-year Investing in Innovation (i3) development grant funded by the U.S. Department of Education. This project's major goal is to increase student engagement and achievement leading to high school graduation and college graduation of low-income, primarily Hispanic, LEP students from the colonias of South Texas, the most economically depressed area in the state. In service of this goal, the project has three main objectives: 1. Establish five PTA Comunitarios in each of the five South Texas public school districts with a minimum of 20 active members; 2. Establish a partnership between PTA Comunitarios and schools through training and technical assistance and 3. Facilitate the design and execution by partners of at least one educational leadership project informed by actionable data for each PTA Comunitario and partner school.

MASS - The Math and Science (MASS) program is a federally funded five year project through which IDRA recruits, prepares, plans and retains a critical mass of highly qualified mid-career professionals and recent graduates as middle and high school math and science teachers with an English as a Second Language (ESL) supplemental endorsement for students in 10 high need Texas school districts. The goal of the project is to produce a rigorous accelerated and unique one and half year program resulting in middle school and high school math or science certification with supplemental ESL endorsement, replicable with other disciplines.

SEMILLITAS - This project responds to the need for educational equity and culturally and linguistically relevant early childhood materials for Latino Native and African American children SEMILLITAS will result in the implementation of an innovative and integrated approach for early childhood equity and educational transformation for vulnerable Latino, Native and African American children in New Mexico.
