With the organization's mission in mind, founders Jennifer Owen and Brad Cox work to bring together some of Kansas City's most talented artists, representing a variety of genres, to perform contemporary dance with live music With diverse backgrounds ranging from the Bolshoi Ballet and the Leningrad Chamber Orchestra, to Alvin Ailey and Dave Brubeck, these dancers and musicians form a highly skilled and multifaceted corps The collaborative results speak for themselves fresh and vibrant new works that are classical in form, but contemporary in expression Two professional dancers donated the equivalent of \$8,332 in services during the fiscal year During 2013-14, the organization created and presented eight (8) performances that served 3,876 people and six (6) educational events serving 1,710 people

Education and outreach are important components to Owen/Cox Dance Group's service to the community The classes in the "Take the Stage" program are directed toward third and fourth graders at schools that are underserved by the arts The classes are rigorous and all-inclusive, and teach that teamwork, tenacity, discipline, and joyful effort can equal success-in academics and in life Every student participates in these high-energy classes that celebrate the best in each child Boys and girls, whether typically developing, with physical or learning challenges or English language learners, ALL are at home in our program Our classes touch upon healthy life practices and what it takes to be your best mentally, physically, and emotionally Students participate in learning different dance moves that are taught by a former dancer and a composer/musician playing the piano Each year the "Take the Stage" program presents students from its full-year schools together on stage in a live-music public performance In 2014, our curricular theme focused on healthy living habits Our Event-of-the-Year Performance held at Rockhurst University in April was titled I Feel Good! Healthy Lessons for Life, with dances focused on the importance of good sleep, healthful eating and exercise The Owen/Cox program "Take the Stage" conducted 145 classes for a total of 160 third and fourth grade students in 2014 Eight culminating performances were held for a total audience of 1,500 parents, teachers, and community members Mid-year performances were held at each participating school, and a final showcase for all full-year schools, at Rockhurst University A professional dance instructor and performance artist donated the equivalent of \$15,800 in services for the education program
