PART I, LINE 2 GRANT MONITORING-	The conference maintains records relative to each of its various grants, as required by NCAA policy The NCAA Conference Grant program is the most substantial and regimented grant that the LSC receives Each year, the commissioner relies on a discussion and feedback with conference governance groups (i e , Council of Presidents, Council of Athletics Administrators, Council of Faculty Representatives) to shape the annual application for the NCAA Conference Grant The conference often times utilizes an ad hoc committee and a survey tool to assist the commissioner in this process For example, the commissioner seeks to engage the entire membership by soliciting input and feedback from the all Presidents, Faculty Representatives, Athletic Directors and Senior Woman Administrators on each campus Each of those employees is asked to complete a survey to help assess the conference's performance across the various Strategic Performance (SPO) areas within the NCAA Conference Grant program Further, the Presidents are encouraged to sit down with the FAR, AD and SWA on campus to discuss the SPO areas, and each of the governance groups are engaged in a conversation with the commissioner at their spring meetings Upon thorough review and discussion of proposed allocations, the Presidents vote to amend/approve the conference's application In determining the allocations, the commissioner considers feedback and direction provided in survey responses and uses a listing of possible initiatives derived from round-table discussions at Division II commissioners meetings Other NCAA grants are handled on a case-by-case basis Such grants, while not as regimented, substantial or likely to occur annually as the NCAA Conference Grant, often times require a specific application, can be used for a specific purpose and require a specific report to be filed Additionally, some grants such as the NCAA Officiating Grant do not require an application or specific usage, but do require a report to account for spending The commissioner normally handles these without the help of others Within the NCAA Conference Grant, funding is sometimes made available in a competitive subgrant program for LSC member schools In such instances, member schools are required to submit an application by a deadline, with the conference staff and ad hoc grant committee then evaluating each request and awarding funds Funds are awarded according to the merits of each request - ensuring the proposed use aligns with this Division II strategic positioning outcome area - and with preference given to new initiatives that could serve as a model program to be implemented on other member campuses In most cases, the dollars distributed are used as seed money to help implement initiatives and/or programming For all spending in the NCAA Conference Grant program, the commissioner must file a comprehensive report at the end of June In addition to detailing expenditures, this report explains the strategy for each initiative, whether the spending helped to fulfill the anticipated outcome and measure its success The report is evaluated by the NCAA Planning & Finance Committee, which has authority to conduct an audit of the conference records, require repayment of funds, impose fines on the conference for wrong-doing or untimely reporting, etc

The Council has ultimate authority in setting the salary. The Commissioner also provides the Council with a listing of self-identified goals for the upcoming year, with the Council approving such goals and then using them as part of the evaluation process for the next year. For the remaining staff positions, comparable data is utilized by the Commissioner in evaluating and recommending salaries. The Commissioner performs evaluations of each employee prior to the annual June meeting for the Council of Presidents, documenting such and compiling a summary report for each employee that is presented to the Council. The Commissioner shares details of each employees performance and recommends the salary for each position, with the Council of Presidents having ultimate authority in setting salaries. Each staff member also provides the Commissioner with a listing of self-identified goals for the upcoming year, with the Commissioner approving such goals and then using them as part of the evaluation process for the next year. All documentation for the Commissioners evaluation and goals is placed in a personnel file that is held in confidence by the current Chair and passed forward annually to each new Chair. Documentation for remaining staff positions is placed in a personnel file for each employee that is held in confidence by the Commissioner. Actions of the Council regarding staff evaluations and salary approvals are recorded in the meeting minutes.
