Albany Middle School: Counseling funds that help to support two full time positions, and longer hours at the library because of a library technician position;

Albany High School: Funding toward three elective sections to enhance choice and flexibility, longer hours at the library because of a library technician/aide, and peer tutoring (FLEX) program to help students who are struggling;

MacGregor High School: Funding towards culinary arts program.
