The new preschool in Tel Aviv had a successful first year with integrated pre-kindergarten class. Outreach work done to enroll new students led to the school tripling in size for the coming year. New programs at HIH Jerusalem high school include film-making, community volunteer work, community garden and more. Fourth high school 12th grade class graduated in June 2014. We ran the 5th annual summer day camp, Project Harmony, on the Jerusalem school campus. We created new curriculum modules for both HIH schools and other public schools in Israel. We held the 3rd national summer teacher training conference. Israel staff increased social media presence of HIH and built wider media coverage across Israel. HIH worked to deal with the challenge of increased violence and racial tensions in Israel. Throughout the summer of 2014 HIH community members held vigils, evening walks under the slogan "Jews and Arabs refuse to be enemies" and engaged the wider public on a continuous basis
4b	(Code:) (Expenses \$ 44,764 including grants of \$) (Revenue \$) UNITED STATES In March 2014 Hand in Hand staff member Rebecca Bardach and Israeli Arab Hand in Hand graduate toured the US and spoke before several hundred people in synagogues, churches and home parlor meetings. Director Lee Gordon recruited new American volunteers to work at Hand in Hand summer camp in Jerusalem in July 2014. Lee Gordon also gave over 30 presentations in cities across the country from Los Angeles to New York. Board chair Stuart Brown presented Hand in Hand at conferences in Washington DC and New York and met with donors and educators in Dallas, DC, Baltimore and Florida. Two other board members, Martha Freedman and Emile Bendit, hosted events in their home towns to educate others about Hand in Hand's program.
