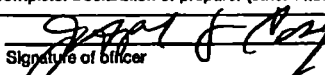

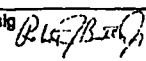

During the past thirty years, Sturdy Memorial Associates has recruited numerous physicians to expand needed primary care and specialty resources in the area. During this time frame, the Sturdy Memorial Hospital service area has not had enough physicians to satisfy the community's needs. Even with all the additional physicians that have been recruited, there is still a need for a number of new physicians to satisfy the expanding population of the twelve communities that are served. Currently, Sturdy Memorial Associates operates sixteen group practices in Attleboro, North Attleboro, Rehoboth-Seekonk, Norton, Foxboro and Plainville serving 228,500 patient visits in the past year.

Schedule D, Part V, Line 4 - Sturdy Memorial Foundation maintains endowment funds (restricted to principal) for the benefit of Sturdy Memorial Hospital and Sturdy Memorial Associates. The investment earnings on the endowment funds are almost entirely unrestricted. As income is earned on the endowment funds (unrestricted as to income), it is transferred to the unrestricted fund (within the Foundation). From time to time, the Board of Directors has authorized transfers from the unrestricted fund in the Foundation to Sturdy Memorial Hospital and Sturdy Memorial Associates. A small portion of the endowment is held in fund with the income restricted for "free care" for patients. The income on this fund is transferred on a semi-annual basis to Sturdy Memorial Hospital and is used as free care in accordance with the hospital's free care policy.

Schedule D, Part X, Line 1 - Sturdy Memorial Foundation, Inc. has provided funding to the Associates to support its purpose of enhancing the medical community of the Attleboro, Massachusetts area. Such funding has enabled the Associates to establish and operate medical practices and acquire the equipment of medical practices within the area. As of September 30, 2014, the Foundation had approved continued support up to \$23,250,000 for this purpose. The limit was raised to \$28,700,000 in November, 2014. The balance as of September 30, 2014 is \$23,250,000.

During CY2013, such payments were made for Bruce Auerbach, MD, and Joseph Casey. Also, the Hospital paid a flat bonus (the same amount to each employee prorated for hours worked) to all Hospital and Associate employees, and announced the net amount (effectively paying the taxes). The Hospital also provides its senior managers with long term disability insurance. The cost of this insurance is grossed up to effectively pay for the related taxes and is added to the managers' gross earnings. During CY2013, this benefit was provided to Bruce Auerbach, MD, Linda Shyavitz, Joe Casey and Pamela Miale.

Schedule J, Part I, Line 1b - As explained in line 1(a) above, there are a few instances where a gross up is used. The Board of Managers approves the Hospital bonus (net of taxes) and the Executive Committee approved the supplemental retirement plan.

Schedule J, Part I, Line 3 - Sturdy Memorial Hospital, Inc. used a compensation committee, compensation survey and received approval by the Hospital's Executive Committee, acting as the compensation committee, to establish the compensation of the CEO.

Schedule J, Part I, Line 4 - Supplemental retirement contributions were made through a non-qualified retirement plan, for senior managers in calendar 2013. Sturdy provided non-qualified retirement to the following key executives: Bruce Auerbach, MD - \$139,772 and Joseph Casey - \$61,281 (all such amounts have been reported on Form W-2). Linda Shyavitz had a provision in her employment contract (expired 3/1/14) that states the termination of her employment by the board results in her receiving her base salary for six months after termination, and for an additional six months or until she finds new employment, whichever is less. Bruce Auerbach, MD has a provision in his employment contract (beginning 3/1/14) that states the termination of his employment by the board results in him receiving his base salary for one year from the date of termination, in bi-weekly payments, net of normal and customary state and federal taxes. During that period, the Hospital will continue to offer him life and health insurance, provided he continues to pay the employee contribution amount for his health insurance.

Incentive compensation provided to Linda Shyavitz, Joseph Casey, Pamela Miale and Bruce Auerbach is paid by Sturdy Memorial Hospital. Incentive and other compensation paid to Dr. Benson is for his employment as a physician and not for services provided as a director of the organization. All incentive compensation is subject to review and approval by the compensation committee of the Hospital and have been reported on Schedule J Part II column Bii.

Form 990, Part V, Line 2a - Sturdy Memorial Hospital is the common paymaster for Sturdy Memorial Associates. Form W-3 is filed under Sturdy Memorial Hospital's employee identification number and included 375 Sturdy Memorial Associate employees.

Form 990, Part VI, Section A, Line 6 - Sturdy Memorial Foundation Inc, a Massachusetts charitable corporation, acting through its Board of Directors, is the sole member of Sturdy Memorial Associates, Inc

Form 990, Part VI, Section A, Line 7a - Foundation members are eligible to attend all meetings of the Corporation and to hold office. New members are elected to membership by the existing members for three year terms. The Member elects and may remove or suspend trustees of Sturdy Memorial Associates.

Form 990, Part VI, Section A, Line 7b - All matters involving real property, including without necessary limitation, sales, leases and purchases, shall first require approval of the Member acting through the Board of Directors of Sturdy Memorial Foundation.

Form 990, Part VI, Section B, Line 11b - The preparation of the Form 990 is the responsibility of the CFO and the Sturdy Fiscal Services department, with review by Sturdy's tax providers, Grant Thornton. The Form 990 is prepared by the finance staff upon completion of Sturdy's annual independent audit and reviewed by the Controller, CFO and Grant Thornton. In addition, compensation and benefit sections are reviewed by the Vice President of Human Resources for Sturdy Memorial Hospital. Prior to filing the Form 990, the complete form and all schedules are provided to every board member and any questions are answered.

Form 990, Part VI, Section B, Line 12c - Sturdy Memorial Associates follows the Conflict of Interest Policy of Sturdy Memorial Hospital, its affiliate. The policy was adopted on May 5, 1995. Under the direction of the Sturdy Memorial Hospital Integrity Officer, all managers and supervisors (including officers and key employees) must complete and sign an annual Conflict of Interest Disclosure Statement. The Statement requires disclosure of any outside interests in any business, outside activity, gifts or entertainment that may have influenced the employee. In addition, the employee must disclose if they have shared any corporate information for their own personal advantage or if they had knowledge of any integrity or ethical issues not previously reported. These signed statements are reviewed by the Integrity Officer and any potential conflicts are resolved. The Integrity Officer discusses disclosed conflicts with the reporter, so that the reporter knows what business activities they cannot participate in (e.g., purchasing decisions, board votes, etc.). Any gifts received, that create a conflict, or are in violation of the Conflict of Interest Policy must be returned or paid for at fair market value. Annually, the Integrity Officer reports, to the Board of Directors, any new conflicts. Article VI of the Associates' by-laws requires Board members to disclose any potential conflict. Board members, officers and key employees must attest in writing each year to any potential conflict. The Conflict of Interest Statements are reviewed by the Executive Director and Chief Financial Officer and any potential conflicts are resolved.

Form 990, Part VI, Section B, Line 14 - Sturdy Memorial Associates does not have a written document and destruction policy but does comply with Massachusetts law with respect to record retention requirements. Where state law does not require retention limits, the Associates uses the "Business Records Retention Schedule" from the Office of the Federal Register and other relevant and reliable sources (such as attorney letters and recommendations from accounting firms). A formal policy has been drafted.

Form 990, Part VI, Section B, Line 15 - The CEO (Executive Director), the CFO and the Director of Operations of Sturdy Memorial Associates are compensated entirely through Sturdy Memorial Hospital which is why there is no compensation in column D. The CEO and senior managers listed above are compensated on a merit system, as part of their compensation review in Sturdy Memorial Hospital. The CEO and senior managers prepare goals at the start of each fiscal year and are evaluated for merit increases based on those goals and their accomplishments relative to the goals. The CEO's accomplishments (relative to the established goals) are documented in an annual report which is submitted to the Chairman of the Board of Managers. The Board Chairman is provided with comparative market data obtained through compensation surveys prepared by an independent consultant specializing in such matters. The comparative data is for similar hospitals in Massachusetts and is sent directly from the independent consultant to the Board Chairman. The data includes comprehensive salary and benefits information for CEO's and senior managers (key employees) including comparison of base pay, incentive pay, benefits and total compensation. In addition, the Chairman is provided with performance information for Massachusetts hospitals obtained through the Center for Health Information & Analysis. The Hospital's Vice President of Human Resources provides the Chairman with the CEO's current actual salary and benefits. The Chairman of the Board of Managers provides the above information along with the annual report of the CEO's accomplishments (relative to established goals including the hospital and the Associates) and a history of the CEO's compensation to the Executive Committee which serves as the Compensation Committee for this purpose. The Executive Committee reviews the comparative data for the CEO base salary, bonus (incentive) and total compensation along with the survey data for

benefits. Based on the goals achieved and the comparative data provided, the Executive Committee votes to approve the salary, bonus and benefits of the CEO. A summary of the discussion and the decision of the Executive Committee are reflected in the meeting minutes. The Chairman of the Board of Managers communicates the decision regarding compensation changes in a letter to the Vice President of Human Resources to execute the change. The CEO uses comparative market data, obtained from an independent consultant, for the hospital senior managers. The CEO compares the senior managers' current base salary and bonus (incentive pay) to the survey data. The senior managers' performance is evaluated based on the goals established at the start of the year. The CEO determines the base pay amount and bonus for each senior manager based on performance and the compensation survey. Base salary and bonus payments for each senior manager, including survey information, are reviewed with the Executive Committee by the CEO. The Executive Committee votes to accept the recommendations of the CEO for all senior managers except the CFO. The Executive Committee votes to approve the CFO's compensation separately.

Form 990, Part VI, Section C, Line 19 - The Associates makes available copies of its by-laws, conflict of interest policy and financial statements to the public upon request.

Form 990, Part VII, Section B, Line 1(A) - Linda Shyavitz, Executive Director and Clerk retired March 1, 2014. At that time, Bruce Auerbach, MD became Executive Director and Pamela Miale, the Director of Operations for Sturdy Memorial Associates, became the Clerk.
