GUIDED BY RECOMMENDATIONS IN EMERALD NECKLACE TREE CONDITIONS ASSESSMENT AND MANAGEMENT PLAN, THE INITIATIVE INTENDS TO PRESERVE HERITAGE TREES IN THESE HISTORIC PARKS, SOME OF WHICH ARE MORE THAN 100 YEARS OLD.
