During fiscal year 2014, Bradley Hospital Foundation (the Foundation) transferred \$306,942 in funds raised to EPBH to support the continued expansion of its Outpatient Services Department, in response to growing demand This transfer included \$90,000 in salary support for the Outpatient Clinic This expansion allows the Outpatient Services Department to better serve the community by reaching more children and families in need of mental health care, as well as improving the quality and environment of that care The 2,284 square foot addition included more space for group therapy which allows Outpatient Services to accommodate the increased patient volume in that area

Through the development and administration of philanthropic activities, the Foundation is able to transfer various funds raised to EPBH to support its operating activities, which in turn benefit the Rhode Island community For example, \$50,225 was provided in support of the Pediatric Mood Imaging Neuro Development program (PediMIND), which uses brain imaging techniques, including magnetic resonance imaging (MRI), behavioral measures, and genetic analyses to identify biological and behavioral markers (scans and tests) of psychiatric illness, including bipolar disorder, in children and adolescents Additionally, \$47,767 was transferred to EPBH to support the implementation of a new Science, Technology, Engineering, and Mathematics Enrichment Initiative at The Bradley School in Portsmouth, Rhode Island Also, \$14,196 was transferred for EPBH's Pediatric Partial Hospitalization Program

The Foundation transferred \$82,000 to the EPBH to support outpatient psychiatric services at the Newport Child and Adolescent Behavioral Health Clinic, a partnership between EPBH and Newport Hospital in Newport, Rhode Island This clinic has been able to help fill the void that existed for Newport County families with limited resources available to help children in emotional distress or psychological crisis

Further review is performed by the Director of Finance and the Vice President of Finance - Corporate Services. Once the draft Form 990 is complete, the Tax Compliance Manager forwards it with all supporting worksheets to KPMG, which then reviews the completed form in detail. The Tax Compliance Manager answers questions as they arise and provides additional information as needed. KPMG provides the Tax Compliance Manager with any recommended changes which are reviewed, and if agreed upon, are incorporated into the return. The draft Form 990 is then provided to the Chief Financial Officer for final management review. Prior to filing the return with the Internal Revenue Service, a copy of the entire form is sent to the Foundation's Board of Trustees in advance of its next Board meeting, at which the Chief Financial Officer discusses the highlights of the Form. All questions and concerns of the members of the Board are addressed by the Chief Financial Officer and incorporated into the Form 990 when appropriate. Once the Form 990 is complete and ready to be filed, the members of the Board are notified via email that a copy of the final version of the Form 990 is accessible through a password protected website portal. The Chief Financial Officer is authorized to file the Form 990.
