On September 9, 2010 the Foundation acquired a \$230,000 receivable that is still currently an asset on the Foundation's balance sheet. Since this asset is not "used" or "held for use" by the Foundation for a charitable, educational, or other similar function that contributed to the charitable status of the Foundation, it is required to be included in calculating the minimum investment return every fiscal year. However, for fiscal years ended September 30, 2010, September 30, 2011, September 30, 2012, and September 30, 2013, it was unintentionally omitted from the calculation. This unintentional omission was recently discovered, and the Foundation is now taking the steps to adjust their distribution overpayment/(underpayment) for this omission.

Had the \$230,000 been included in the minimum investment return calculation since September 9, 2010, the excess distributions carryover from September 30, 2013 would have decreased from \$28,878 (as reported in the Form 990-PF) to an Under Distribution of \$5,756 as follows:
