

Most of the money we make goes directly to school fees and school expenses for orphans and vulnerable children in Zimbabwe. In total, we fund 43 students. Of these, 25 students attend local day schools (\$ 26,308), 5 students attend boarding schools (\$ 16,662), 10 attend post-secondary technical schools (\$ 27,987) and 3 attend university (\$ 8,651). The average spent per child is \$ 1,851. In addition, we cover field trips and team-building (\$ 10,765), incentives and awards dinners for good grades (\$ 4,078), medical costs (\$ 1,600), emergency food aid (\$ 2097), and extra lessons (\$ 5538). On the amended version the total number was increased by 3 to account for a typo.

This year our administrative expenses included \$ 6,575 for 3 flights to Zimbabwe, \$ 624 in bank fees, and \$ 630 in office supplies.
