Catherine McAuley MERCY Foundation helps to provide the financial resources for Sisters of Mercy Services Corporation (SOMSC), Sisters of Mercy Urgent Care (SOMUC) and other organizations identified and associated with these organizations important work. The Foundation, which is the fundraising arm of the not-for-profit Sisters of Mercy Services, helps purchase medical equipment for our urgent care facilities and send relief teams and supplies to Haiti.

During Fiscal Year 2014, the Foundation directly contributed \$7,086 to Brevard Urgent Care/Frances Warde Family Health (FWFH) for purchase of a new defibrillator, scales and laptop computer.

Brevard Urgent Care and FWFH, both located in Brevard, NC, saw a combined total of 6,118 patients in FY 14

Primary-care services are offered through Frances Warde Family Health in Brevard. This practice offers a diabetes education and treatment program in conjunction with Transylvania Regional Hospital

During FY 14, \$22,763 of direct expenses were used toward our medical mission program in Haiti. Staff and other volunteers from Sisters of Mercy Urgent Care and Sisters of Mercy Service Corp. provided care to 2,585 Haitian patients during 3 mission trips.

The internal cost of preparation and value of volunteer time is estimated to be around \$52,037.

Equipment and medication valued at over \$136,000 was donated to the Alpha and Omega Haitian Clinic run by Haitian Doctors, Vlad and Merline Roseau, who we have supported since the earthquake of 2010

In November/December 2013, three staff members (2 MDs and a paramedic) flew to the Philippines after typhoon Haiyan devastated the country. Our team, who partnered with North Carolina Baptist Men (NCBM), saw many countless patients for three weeks.

The value of volunteer time is estimated to be around \$26,400. Medications expense, purchased by the Foundation, amounted to \$2,305. Travel, room and board were covered by NCBM

The medical team was serving approximately 80 people per day at an evacuation center at a local school in Tacloban City
