Live the Solution (LTS) is a service oriented organization whose primary programs AZ Earn to Learn (AZEL) and Employer Assisted Housing (EAH) AZEL is Live the Solutions groundbreaking new program, which provide financial education and scholarships to low-income transfer students and high school students who will pursue post-secondary education during their junior and/or senior year in high school or as an incoming student at one of the three major state universities University of Arizona (UA), Arizona State University (ASU), or Northern Arizona University (NAU) The overarching goal of AZEL is to provide financial assistance to increase the number of low-income students attending one of the aforementioned universities, while providing practical financial education to help them become successful students and citizens The EAH program provides eligible employees of partner institutions with an increased opportunity to become first-time homeowners in Tucson, Arizona LTSs program provides a comprehensive approach of matching participant savings, facilitating no-cost personal finance workshops, and providing one-on-one financial coaching This program helps working families secure affordable housing, often near their workplaces Consequently, employers are able to keep qualified workers, improve community relations, and have a positive effect on the economy as a whole EAH is an especially powerful tool for employers struggling with recruitment and retention In addition, it leverages an employer benefit to generate neighborhood revitalization and help meet the housing needs of low- and moderate-income working families Over the past few years, LTS has been incredibly successful in helping dozens of individuals and families become homeowners
