From 990-EZ, item 10 (grants and other amounts paid), Givology made numerous grants to our many partner organizations, the largest of which were to the Peach Foundation (\$6,000), Shining Hope for Communities (\$3,470), Starfish One by One (\$2,065), the Turning Point Trust (\$2,407), AMCAV (\$2,000), the Emmaus Road Foundation (\$1,917), and Flying Kites (\$1,242). An additional \$4,481 in grants was paid to 9 other partners.

For 990-EZ, item 16 (other expenses), \$869.88 was spent on a variety of financial fees - \$60.00 on bank wire fees, and \$809.88 on credit card processing fees.
