THE DISCRETIONARY PORTION OF THE TRUST CONTAINS 75% OF THE ORIGINAL CONTRIBUTIONS TO THE TRUST. THESE FUNDS ARE AVAILABLE FOR DISTRIBUTION TO THE OVERBROOK LIBRARY BOARD TO CONSTRUCT OR ACQUIRE A NEW LIBRARY FACILITY OR RENOVATE OR EXPAND THE EXISTING LIBRARY FACILITY. THE INCOME IS DISTRIBUTED SEMI-ANNUALLY TO THE LIBRARY BOARD FOR MAINTENANCE AND OPERATING EXPENSES.

THE ENDOWMENT PORTION REPRESENTS 25% OF THE ORIGINAL CONTRIBUTIONS TO THE TRUST. THE INCOME FROM THE ENDOWMENT PORTION IS DISTRIBUTED SEMI-ANNUALLY TO THE OVERBROOK PUBLIC LIBRARY BOARD FOR USE IN ITS OPERATING BUDGET. THE PURPOSE OF THE INCOME DISTRIBUTIONS IS TO DEFRAY THE EXPENSE OF MAINTENANCE, UTILITIES, STAFF, AND GENERAL OPERATING EXPENSES.
