This matter came before the Court on the Complaint of William E. Spooner, William A. Wells and William E. Evans, each in his capacity as a Trustee of the Endowment and Development Fund of the International Brotherhood of Magicians (collectively, "Plaintiffs" or "Current Trustees"), seeking modification of the Trust under Section 5804.12, Division (A) of the Ohio Revised Code.

The Court, having reviewed the pleadings, other filings and the complete record before it, hereby finds and orders as follows:

1. On November 13, 1973, the International Brotherhood of Magicians, an Ohio not-for-profit corporation ("IBM"), established a Trust known as the Endowment and Development Fund of the International Brotherhood of Magicians (the "Trust").

2. The Current Trustees, William E. Spooner, William A. Wells and William E. Evans, have each been duly appointed by the Board of Directors of the IBM pursuant to its authority under Paragraph 7 of the Trust.

3. The court has venue over this matter pursuant to Ohio Civ. R. 3(B)(13)(b) as the statutory agent for the Defendant, IBM is a resident of Hamilton County, Ohio

4. Defendant, Michael DeWine, Attorney General of the State of Ohio, is named as a party to this action as required by Section 109.25 of the Ohio Revised Code, to represent the interests of beneficiaries of charitable trusts.

5. Defendant, IBM, has waived service of the Complaint, entered its appearance as a Defendant in this action and consented to the relief requested in the Complaint, as evidenced by its Waiver and Consent filed with this Court.

6. Defendant, Michael DeWine, Attorney General of the State of Ohio, has been duly served and has had the opportunity to review the content and merits of this action with counsel. Defendant, Michael DeWine, Attorney General of the State of Ohio, has entered his appearance as a Defendant in this action and consented to the relief requested in the Complaint, as evidenced by his Waiver and Consent filed with this Court.

7. The Trust is exempt from taxation under section 501(c)(3) of the Internal Revenue Code, and, as required by that section, its purpose is limited to charitable purposes and stated in Paragraph 1 of the Trust as follows: "This trust is created and shall be operated exclusively for charitable, scientific, literary, or education purposes, or for the prevention of cruelty to children or animals, within the United States or any of its possessions."

8. Paragraph 4 of the Trust limits the use of the Trust funds to the purpose stated in Paragraph 1, and Paragraph 11 permits the Trust to be amended by the Board of Directors of IBM if the amendment does not alter the purpose stated in Paragraph 1.

9. The language of Paragraphs 1, 4 and 11 limiting the purpose and use of the Trust funds to charitable purposes "within the United States or any of its possessions" is not a requirement for tax exempt status under 501(c)(3)

10 The IBM is an international organization with 11,000 members in 88 countries.

11 The Trust was originally funded with approximately \$400, and the current value of the Trust is over \$662,000.

12. Division (A) of Section 5804.12 of the Ohio Revised Code provides that “[t]he court may modify the administrative or dispositive terms of a trust or terminate the trust if because of circumstances not anticipated by the settlor modification or termination will further the purposes of the trust. To the extent practicable, the court shall make the modification in accordance with the settlor's probable intention.”

13. The Court finds that at the time it established the Trust, IBM (the settlor) did not anticipate the significant increase in the value of the Trust or the scope of its international activities.

14. The Court finds that modification of the Trust as requested in the Complaint is in accordance with IBM's (the settlor's) intention, as evidenced by its Waiver and Consent filed with this Court.

THEREFORE, IT IS HEREBY ORDERED THAT:

(A) Paragraph 1 is modified as follows:

“1. PURPOSE OF TRUST. This trust is created and shall be operated exclusively for charitable, scientific, literary, or education purposes, or for the prevention of cruelty to children or animals. No part of the trust fund shall inure to the benefit of any private shareholder or individual, and no part of the activities of this trust shall consist of carrying on propaganda, or otherwise attempting to influence legislation, or of participating in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision hereof, this trust shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization which is tax exempt or by an organization donations to which are deductible from taxable income to the extent allowed by the provisions of the Internal Revenue Code and other applicable legislation and regulations as they now exist or may hereafter be amended.”


(B) Paragraph 4 is modified as follows:

“4. USE OF TRUST FUND. The Trustees shall apply the trust fund, at such time or times, in such manner, and in such amounts as they may determine, or as may be required by restricted donations, to the uses and purposes set forth in paragraph 1, or they may make contributions to other charitable organizations. For this purpose, the term “charitable organizations” shall mean a corporation, trust or community chest, fund, or foundation, organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes, or for the prevention of cruelty to children or animals, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation, and which does not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office. Any other provisions of this agreement notwithstanding, the Trustees shall distribute the trust income for each taxable year at

such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code, or other corresponding provisions of any subsequent federal tax laws.”

(C) Paragraph 11 is modified as follows:

“11. AMENDMENT. This agreement may be amended or modified from time to time by the Board of Directors of the Donor whenever necessary or advisable for the more convenient or efficient administration of this trust or to enable the Trustees to carry out the purpose of this trust more effectively, but no such amendment or modification shall alter the intention of the Donor that this trust be operated exclusively for religious, charitable, scientific, literary, or education purposes, or for the prevention of cruelty to children or animals, and in a manner which shall make this trust tax exempt and the donations to it deductible from taxable income to the extent allowed by the provisions of the Internal Revenue Code and other applicable legislation and regulations as they now exist or as they may hereafter be amended. Every amendment or modification of this agreement shall be made in writing, shall be signed by two officers of the Donor pursuant to authority of its Board of Directors, and shall be delivered to each of the Trustees then in office.”




