The animals background ranges from former pets that can no longer be cared for, animals retired from the circus, surplus cats from zoos. By giving them a home, these animals are saved from euthanization. The organization provides medical care for the cats, and incorporates them into an educational program designed to education the public about the plight of exotic cats. Thousands of individuals take part in guided tours of the refuge, where they have an opportunity to see and learn more about the exotic cats.
