 Publishing - Each year, Mission Eurasia helps to cultivate a Next Generation of Christian authors within the former Soviet Union (FSU)/Eurasia by overseeing the publication and distribution of 10-12 titles that are used for leadership development through School Without Walls (SWW), conferences, and pastoral training seminars. Each title allows young Christian authors to present solutions to the challenges facing the evangelical church and society. We also print and distribute thousands of Scripture pieces throughout the FSU/Eurasia, including New Testaments, Bibles, Hope Magazine, and gospel booklets for children. In 2014, more than two million people were reached through these efforts.

4b (Code _____) (Expenses \$ 620,013. including grants of \$ 214,364.) (Revenue \$ _____)
 School Without Walls - SWW is Mission Eurasia's nonformal Christian leadership training program designed to train, equip and mobilize the Next Generation in the FSU/Eurasia to transform their nations for Christ. Through SWW, young people have the opportunity to learn about the Bible while participating in various ministry outreaches in their communities. During the 2013-2014 school year, SWW trained a total of 2,509 students in 13 countries of the FSU/Eurasia, and Israel. We estimate that more than 1,110,000 people were impacted for Christ through this program in 2013-2014.

 Relief Work/GIK - Through humanitarian aid (GIK) distribution, Mission Eurasia ministers to those in need in the FSU/Eurasia. Each year, thousands of people are reached through the distribution of:
 - Gifts of Hope boxes, which contain toys, candy, and a children's Scripture piece, and are distributed by SWW students during the Christmas season.
 - Clothing, food, wheelchairs, and other items, which are distributed by SWW students and volunteers from local churches. In 2014, in response to the crisis in Ukraine, we created our "I Care" Refugee Assistance Program to provide aid for displaced people suffering in the nation.


