PHYSICIAN SERVICES - THE ORGANIZATION OPERATES A 68-PROVIDER PRACTICE DBA BLESSING PHYSICIAN SERVICES (BPS) DURING FY2014, THE PROVIDER GROUP WELCOMED FOURTEEN NEW PROVIDERS, BRINGING THE TOTAL NUMBER TO 59 EMPLOYED AND 9 CONTRACTED PROVIDERS COVERING 20 MEDICAL SPECIALTIES. DURING THE YEAR, BPS PROVIDED 116,936 PATIENT VISITS AND EMPLOYED 255 PEOPLE. WITHIN THESE PROVIDER PRACTICES, IT IS THE POLICY OF THE ORGANIZATION THAT NO ONE IS TO BE DENIED HEALTH CARE FOR INABILITY TO PAY.
