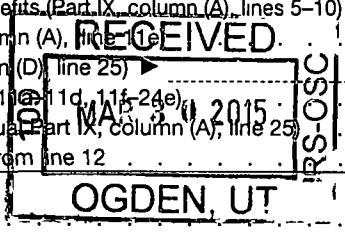

Agency's Chief Financial Officer, who is a Certified Public Accountant, and reviewed by it's Chief Executive Officer.

It is received and approved by the Agency's Finance and Audit Committee, and ultimately the full Board of Directors.

Form 990 Part VI, Section B, Line 15 - Review of compensation of Chief Executive Officer. The Agency's Executive

Committee performs an annual evaluation of the CEO, which includes performance evaluation and compensation

comparability. The Executive Committee then makes a recommendation to the full Board of Directors.

to the public upon request. The Agency's Audited Financial Statements are posted on it's website and more current

financial statements are available upon request.
