THE BTBL COLLECTION INCLUDES MORE THAN 12,271 DIGITAL TITLES, 10,615 BRAILLE TITLES AND 650 DESCRIBED VIDEOS. EVENTUALLY THE CIRCULATION OF CASSETTE BOOKS WILL CEASE AND ALL TALKING BOOKS WILL BE PROVIDED IN DIGITAL FORMAT.
