THE BOARD FOR HOUSE OF HOPE GREEN BAY, INC ACTED WITH DUE DILIGENCE WHEN HIRING THE EXPERIENCED CPA TO PERFORM THEIR YEAR END ACCOUNTING AND TAX WORK. THEY RELIED ON HIS PROFESSIONAL CREDENTIALS AND HIS REPRESENTATION THAT HE WAS MORE THAN QUALIFIED TO PERFORM THE REQUIRED DUTIES AND MEET ALL DEADLINES. THE CPA CONTINUOSLY MISLED THEM BY CLAIMING EVERYTHING WAS UNDER CONTROL.
