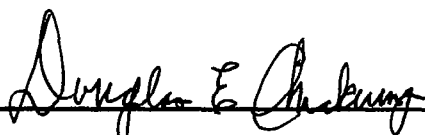

BYLAWS

WISCONSIN RETIRED EDUCATORS' ASSOCIATION FOUNDATION, Inc.

Revised and Restated – January 20, 2014

Article I. NAME

The name of the foundation is the Wisconsin Retired Educators' Association (WREA) Foundation, Inc., hereafter referred to as the Foundation.

Article II. PURPOSE

The Foundation is formed to support the purposes of public education by using methods such as: student scholarships, teacher grants and outreach programs to the community, continuing education and life-long learning, and to enhance and foster volunteerism. These purposes and activities are designed to be within the precepts of Chapter 181 of the Wisconsin Statutes and with federal taxation exemption under Internal Revenue Code 501(c)(3). The purposes of the Foundation are also expressly limited by the restrictions that are set forth in the Articles of Incorporation.

Article III. FUNDING

The Foundation is funded primarily through contributions made by members of WREA, by friends and supporters of WREA, and by grants, including those from foundations whose purposes are similar to the Foundation and which qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or any successor provision. The Board of Trustees adopts policies governing contributions and public recognition of donors.

Article IV. ORGANIZATION

- Section 1. The principal office of the Foundation is 6405 Century Avenue, Suite 201, Middleton, WI 53562.
- Section 2. Management of the affairs of the Foundation is vested in a Board of Directors also referred to as the Board of Trustees.
- Section 3. Board of Trustees -
- a. Composition – Upon the adoption of these revised and restated bylaws, the Board of Trustees is comprised of (7) individuals who are all members of the Wisconsin Retired Educators' Association.
 - b. The Board of Trustees includes, as a voting member, the Immediate Past-President of WREA who is the designated Foundation Liaison to the WREA Board of Directors. Should the Immediate Past-President not be able to serve, the Trustees may select another individual from the WREA Board of Directors to fill the position and act as the Liaison to the WREA.

- c. The executive director of WREA is the executive director of the Foundation and is a non-voting ex-officio member of the Board of Trustees.
- d. The officers of the Foundation shall be the President, Vice President, and Secretary/Treasurer, and they shall have authority to carry out the duties prescribed in these bylaws. One person may hold more than one office, except no person may hold the office of President and Secretary/Treasurer. Officers are elected from the Board of Trustees to serve a two-year term.
- e. The Board of Trustees membership:
 - 1. The current Foundation Board in existence on January 20, 2014 will vote and approve the members of the initial Board of Trustees.
 - 2. Three members will be elected to an initial term ending in 2014 and three members to a term ending in 2015. All subsequent terms will be in accordance with Section 3. e. 3.
 - 3. Members will serve staggered two-year terms with three persons being elected each year.
 - 4. The President, Vice-President, Secretary/Treasurer are elected by the Board of Trustees from their membership to serve two full-year terms, except the initial term which may be shorter pursuant to Section 3. e. 2.
 - 5. The Foundation Trustees (with the exception of the Foundation Liaison) may not serve concurrently in any capacity on the WREA Board of Directors.
 - 6. Terms of Office begin on October 1 and end on September 30.
 - 7. Board of Trustee members, except the WREA Past-President position, may serve on the Board for no more than three successive terms. The Past-President or the replacement trustee as selected under Section 3. b. will serve for a two year term only, and may not be extended, so the successor Past-President or the replacement can timely serve in the trustee position.

Section 4. Election and Vacancies –

- a. Trustees of the Foundation shall be elected by vote of a majority of the Board at the annual meeting.
- b. The Nominating Committee is composed of three individuals and is appointed by the Board of Trustees President. The Committee will report to the Board of Trustees 14 days prior to the annual meeting. Additional nominees may be offered at the annual meeting.
- c. Interim vacancies may be filled by appointment of the Foundation President, except an interim vacancy of the Past-President serving as the Liaison to the Board of Trustees, which will be replaced in accordance with Section 3. b.
- d. Any Trustee may be removed from the Board by a vote of the majority of the Board.
- e. A quorum of the Board of Trustees at any meeting consists of four (4) of its seven (7) members.

Section 5. Board Meetings –

- a. The Board of Trustees has the exclusive authority to manage the affairs of the Foundation in accordance with the provisions of these bylaws, the Articles of Incorporation, and the special restrictions that apply to the Foundation as an exempt 501(c)(3) corporation.

- b. The Board of Trustees meets a minimum of once a year to conduct the business of the Foundation. Special meetings may be called by the President of the Foundation or a majority of the Board of Trustees. Persons authorized to call special meetings shall provide notice of the time and location of such meetings and state the purpose thereof, and no other matter shall be considered by the Board of Trustees at such special meeting except upon unanimous vote of all Directors present. Meetings of the Trustees may be conducted via electronic media to include, but not limited to phone conferencing, online conferencing, etc.
- c. Notice of regular meetings and special meetings to the Trustees should be in a written form, but may include electronic notification, and shall be provided within a reasonable time frame before a meeting. Attendance at any meeting shall be considered waiver of the notice requirement thereof.
- d. All members of the Foundation Board of Trustees serve as volunteers without remuneration except for the reimbursement of expenses incurred in carrying out their responsibilities.

Section 6. Annual Meeting –

- a. There will be an annual meeting, chaired by the Foundation President, at a time and place to be determined by the Board of Trustees.
- b. An Annual Financial Report will be made available to the WREA membership.

Article V. OFFICERS

The officers of the Foundation are the President, Vice-President, and Secretary/Treasurer. Officers are elected in even numbered years by the Board of Trustees from their membership and serve a term of two-years. Officers may be re-elected to their positions.

Section 1. Duties of the officers

- a. The President is the presiding officer of this Foundation and will, subject to the control of the Board of Trustees or any Committees, supervise and control the affairs of the Foundation. The President will perform all duties incident to the office of President and any other duties that may be required by these Bylaws or prescribed by the Board of Trustees.
- b. The Vice-President will perform all duties and exercise all powers of the President when the President is absent or is otherwise unable to act. The Vice-President is the Parliamentarian of the Foundation. The Vice-President will perform any other duties that may be prescribed by the Board of Trustees.
- c. The Secretary/Treasurer will be responsible for:
 - i. ... keeping the minutes of all meetings of Members and of the Board of Trustees, be the custodian of the corporate records, give all notices as are required by law or by these Bylaws, and generally perform all duties incident to the office of Secretary and any other duties as may be required by law, by the Bylaws, or which may be assigned by the Board of Trustees, and
 - ii. ... have charge and custody of all funds of this Foundation, and will deposit the funds as required by the Board of Trustees, keep and maintain adequate and correct accounts of the Foundation's properties and business transactions, and render reports and accountings to the Trustees. The

Treasurer will perform all duties incident to the office of Treasurer, and any other duties that may be required by these Bylaws or prescribed by the Board of Trustees.

Article VI. FISCAL YEAR and BUDGET

- Section 1. The fiscal year for the Foundation is October 1 through September 30.
- Section 2. An annual budget is prepared by the Executive Director for approval by the Foundation Board of Trustees.
- Section 3. An Annual Report will be generated that provides the financial status of the Foundation including donations and dispersals of its funds.
- Section 4. All disbursements shall be made by check or by authorized electronic transfer.

Article VII. AMENDMENTS

These bylaws may be amended by the Board of Trustees at any duly called meeting of the Board of Trustees.

Article VIII. DISSOLUTION

In the event of circumstances which cause the dissolution of the Foundation, all funds and capital assets of the Foundation shall be transferred to any successor organization or disbursed to such not-for-profit educational or charitable agencies or institutions as the Foundation Board of Trustees shall designate as specified in the Articles of Incorporation.

Article IX. PARLIAMENTARY AUTHORITY

The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the WREA Foundation in all cases to which they are applicable and in which they are not inconsistent with these bylaws and any special rules of order the Foundation may adopt.
