Producer Services (PS) Team The PS team has a broad and diverse list of organizations with whom it partners In addition to promoting and educating people about corn and corn farming and the items necessary to conducting those activities, the PS team supports projects such as venues at the Minnesota State Fair, Children's and Minnesota Historical Society Museums, and some two dozen tradeshows each year The PS team has and continues to sponsor work conducted by more than 100 community, state, regional and national groups Matching programs that support the activities of forty-six county corn organizations are funded through this team with another six counties expected to affiliate with MCGA in the coming year In fiscal year 2014, eight regional representatives assisted our county affiliates and participated in more than 200 events

Production Stewardship (SP) Team The SP team invests resources between 15 and 25 projects each year in the areas of optimizing crop production and conserving soil and water quality In the last year, the team has set up long-term support of an all-new nutrient management position at the University of Minnesota The Minnesota Agriculture Water Resources Center and Minnesota Discovery Farms Initiatives are notable successes under the purview of SP team

Food & Bioenergy (FAB) Team The FAB team supports several projects and initiatives involving food and fuel - the bio-based energy and the livestock sectors FAB team projects are as diverse as support for national ethanol initiatives such as BYO Ethanol, Growth Energy Market Development, and the American Coalition for Ethanol to Minnesota Clean Air Choice Coalition's Fueling Infrastructure and consumer education efforts conducted by the American Lung Association in Minnesota In the last year, the team acted as an organizer and founding supporter of the Farm & Food Alliance of Minnesota, which assists livestock producers in their care of animals

Expanded Uses (EU) Team The Expanded Uses team focuses on finding new uses for corn and corn co-products developed through milling and chemical processes The EU team's research emphasis has been in the areas of livestock nutrition, co-product enhancement, biomass collection/processing, biofuel engine performance testing, and value added bio-based technologies The major initiative for the EU team is the generation of the National Agricultural Genotype Center The Genotype Center will speed the beneficial advances in seed technology and inputs for the maize genome database and will make discoveries available to the entire corn industry to keep it viable for years to come CommunicationsNumerous communications via broadcast, web-based, outdoor, special event, and print media activities are conducted each year through Minnesota's corn organizations The communications efforts result in hundreds of millions of media impressions throughout the state and region in addition to base communications projects planned and executed each year Focus teams and committees direct special projects to communications staff when they involve a communications component These may range from straight forward, one-time newspaper advertisements associated with an event or tradeshow, to months-long, multi-partner, coalition-based campaigns Communications staff also oversee social media activities for the organization and act as the point of contact for journalists
