THE HAVEN OF HOPE IS A SHORT-TERM HOUSING AND ADVOCACY PROGRAM FOR WOMEN AND CHILDREN FLEEING DOMESTIC VIOLENCE. THE WOMEN'S CENTER PROVIDED SHELTER FOR 63 WOMEN AND 58 CHILDREN DURING THE PERIOD. THE ORGANIZATION ALSO MAINTAINS A 24-HOUR CRISIS LINE, PROVIDES OUTREACH SERVICES, LOCAL SUPPORT GROUPS AND COMMUNITY EDUCATION. DOMESTIC VIOLENCE CRISIS CALLS TOTALLED 297. LEGAL ADVOCACY WAS PROVIDED TO 74 CLIENTS. A TOTAL OF 16,858 SERVICES WERE PROVIDED TO 193 WOMEN, 58 CHILDREN AND 13 MEN.
