	Established in 2000 with a generous grant from the Siragusa Foundation, the Siragusa Scholarship Fund for special needs adoptive families enables The Cradle Foundation to provide financial assistance to dozens of families each year whose children face unique challenges. Cradle adoptive families can apply for awards up to \$1,500 annually for needs ranging from therapy to medication to special equipment. In fiscal 2014 the Siragusa Scholarship Committee distributed awards to 32 Cradle families on behalf of 35 children.
