IN DECEMBER 2013, WESTERN RIVERS FORESTRY ACQUIRED 8,489 ACRES OF LAND ALONG VITAL TRIBUTARIES TO NORTHERN CALIFORNIA'S KLAMATH RIVER. THE DECEMBER 2013 CLOSING INCLUDED THE FIRST 4,726 ACRES IN THE BLUE CREEK SALMON SANCTUARY. IN ADDITION, LANDS IN THE BEAR AND PECWAN CREEK WATERSHEDS, TOTALING 3,763 ACRES, WERE ADDED TO THE YUOK TRIBAL COMMUNITY FOREST. THE YUOK TRIBE IS NOW MANAGING THESE LANDS ON BEHALF OF WESTERN RIVERS FORESTRY AND IN LINE WITH OUR CONSERVATION VISION. THESE LANDS WILL ULTIMATELY BE CONVEYED TO THE YUOK TRIBE TO HELP ENSURE THE SURVIVAL OF SALMON AND STEELHEAD THROUGHOUT THE KLAMATH SYSTEM AND PROTECT VITAL WILDLIFE HABITAT WITHIN ONE OF THE MOST BIOLOGICALLY DIVERSE REGIONS ON THE PLANET.
