KANSAS FARM BUREAU'S VOICE OF AGRICULTURE RADIO PROGRAM IS A BROADCAST-DELIVERED COMMUNICATIONS PROGRAM THAT REACHED A MAJORITY OF THE TARGET LISTENING AUDIENCE (ADULTS 18+) WITH A MESSAGE SPONSORED BY THE FARMERS AND RANCHERS OF KANSAS FARM BUREAU ABOUT RELEVANT AGRICULTURE-RELATED INFORMATION AND ISSUES. THE AUDIO PROGRAMS WERE CREATED TO PROVIDE TARGET LISTENERS WITH VITAL NATIONAL AND STATEWIDE AGRICULTURE NEWS AND ISSUES THAT CAN IMPACT AGRICULTURE AND THE LIVES OF PEOPLE ACROSS KANSAS. THE AUDIO PROGRAM WAS STRUCTURED AS A ONE-MINUTE DAILY NEWS FORMAT THAT AIRED AN AVERAGE OF THREE TIMES PER DAY, FIVE DAYS PER WEEK (M-F), 52 WEEKS (780 TIMES) PER YEAR. THE AUDIO PROGRAM AIRED BETWEEN 6 A.M. AND 7 P.M. ACROSS THE STATE ON MULTIPLE RADIO NETWORKS COMPRISING MORE THAN 40 RADIO STATIONS THAT HAVE A SIGNIFICANT NUMBER OF TARGET LISTENERS. THE TARGETED LISTENING AUDIENCE HEARS SEVERAL RADIO PROGRAMS PER WEEK AND 100-200 PROGRAMS PER YEAR.
