Part V, Line 34	The Wisconsin REALTORS Foundation executed a Restatement of the Articles of Incorporation modifying the purposes to more broadly state than the previous version from 1994 that the organization is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The Articles of Incorporation also now state that the purposes shall be set forth in the Corporation's bylaws rather than attempting to list each purpose within the Articles of Incorporation. The Articles of Incorporation also modified the makeup of the Foundation board of directors to be no less than three and now also defers to the Foundation bylaws for the selection and duties of the board. The Wisconsin REALTORS Foundation bylaws were also modified. In general, the bylaws now include an additional purpose to clearly permit the Foundation to engage in and support charitable and educational activities consistent with Section 501(c)(3) of the Internal Revenue Code. The bylaws also modified the number of the Board to consist of at least three (3) but not more than nine (9) persons, the bylaws modified the composition and qualifications of persons to include those who support the purpose of the Corporation and who provide representation of various constituencies, geographic areas, and industry sectors, and may include but is not limited to representation from real estate professionals and members of the Realtor association, the changes modified the role of the organization's officers to include a chairperson, vice-chairperson, secretary, and treasurer as well delineates clearly the role of each officer and responsibilities, the bylaws changes created an executive director position and said authorities of the positions, the bylaw changes permit the board to have an executive committee and other standing committees as determined by the board and who shall participate in the executive committee if created, also permits the board from time to time to create advisory boards and creates a selection process and role of the advisory board, the last significant change provides the board the ability to from time to time establish or amend a statement of policies regarding the receipt, management and investment of contributions to the Corporation, the types of research projects to be sponsored or funded by the corporation, and the qualifications for persons conducting these projects as well as requiring a specific majority vote and approval process for such changes.
